

Fruitvale Station DVD Sweepstakes OFFICIAL SWEEPSTAKES RULES

This Sweepstakes will be conducted exclusively online. Five (5) winners will each be awarded One (1) copy of the movie 'Fruitvale Station' on DVD. ("Prize") (Prize ARV = \$20.00\$20) (Total Prize ARV = \$100.00).

HOW TO ENTER / EXECUTION:

Visitors to www.HelloBeautiful.com ("Participating Website"), who are legal residents of the United States, and are 18 years of age or older will be able to enter and take part in this Sweepstakes (Qualified Entrant). To enter the Sweepstakes, Visitors must:

1. Visit [Participating Website](#).
2. Upon entering the Participating Website, Visitors will be prompted to use RaffleCopter's widget in order to enter Sweepstakes, however, Visitors may elect to use the alternate means of online entry described below.
3.
