

**Fruitvale Station DVD Sweepstakes
OFFICIAL SWEEPSTAKES RULES**

SWEEPSTAKES DESCRIPTION:

The Fruitvale Station DVD sweepstakes (“Sweepstakes”) will begin on Monday, February 3, 2014 and end on Friday, February 7, 2014 (“Sweepstakes Period”). This Sweepstakes will be conducted exclusively online. Five (5) winners will each be awarded One (1) copy of the movie ‘Fruitvale Station’ on DVD. (“Prize”) (Prize ARV = \$20.00\$20) (Total Prize ARV = \$100.00).

HOW TO ENTER / EXECUTION:

Visitors to www.HelloBeautiful.com (“Participating Website”), who are legal residents of the United States, and are 18 years of age or older will be able to enter and take part in this Sweepstakes (Qualified Entrant). To enter the Sweepstakes, Visitors must:

1. Visit [Participating Website](#).
2. Upon entering the Participating Website, Visitors will be prompted to use RaffleCopter’s widget in order to enter Sweepstakes, however, Visitors may elect to use the alternate means of online entry described below.
3. Visitors will be asked to enter certain registration information, including entering their name and email address and any other optional or additional contact information (“Registration Information”), as requested, to register for a chance to win. Through the RaffleCopter.com widget, users can enter Sweepstakes either by entering their Facebook log-in information or their email address.

10. One entry per person per day per email address or Facebook account during the Sweepstakes Period.

12. Winners will be selected by random drawing from among all eligible entries received electronically. Winners will be notified by email.

ELIGIBILITY RESTRICTIONS:

1. The Sweepstakes is open to Qualified Entrants only.
